# Australia

## Permanent Resident Visa

It is a 5 year multiple entry Permanent Resident Visa. To retain the resident status a Permanent resident need to live in Australia for 2 out the each 5 years period of validity. After 4 years of stay in Australia a permanent resident can apply for citizenship

### Eligibility:

- Australia accepts applications under general skilled, employer nomination and state nomination programs;
- Diploma, Bachelor's or Master's Degree; master's degree does not get extra credits in the overall pass mark count;
- Relevant work Experience of 2 years onwards; in some occupations one can apply after one year full time relevant work experience;
- Skills assessment is a crucial and starting stage of application eligibility process. Under process that will become applicable with effect from 1<sup>st</sup> July, 2012, the applicant – with positive skills assessment and required IELTS score – will file an Expression of interest (EOI) application. The EOI application will stay in the pool for up to a maximum of 2 years. If and after the application is selected and invited from the pool, the applicant can file his application for permanent resident visa.
- IELTS required (General or Academic Module); module and required IELTS depends on the applicant's occupation, skills assessment body and where applicable, on state that is nominating him;
- Spousal qualifications and experience can make positive contribution to eligibility in select cases;
- Eligibility criteria for Australia undergo significant changes in July, 2012 and new pass mark and application process is being introduced and become applicable. ABHINAV is now assessing application for qualified candidates as per new pass marks and filing their skills assessment applications with relevant agencies.



# Australia

## Permanent Resident Visa

# Canada-Federal Skilled Worker Program

It is a 5 year multiple entry Permanent Resident Visa. To retain the resident status a Permanent resident need to live in Canada for 2 out the each 5 years period of validity. After 3 years of stay in Canada a permanent resident can apply for citizenship. A Canadian citizen is allowed to work with employers in USA without H-1/L-1 and against USA employer job offer and TN visa.

## Eligibility:

- Canada accepts skilled applications under federal, provincial and Quebec programs
- Diploma, Bachelor's or Master's Degree;
- Work Experience of 1-4 years or more; Canada is one destination where experience – even if it is not related to earned qualifications is accepted;
- Canada has very flexible selection criteria as regards experience; one can qualify against just one year experience in the qualified occupation. Rest of the experience is counted towards overall pass-mark point count even when rest of the experience is not related to qualified occupation;
- Canada has liberal policies on crediting points for spousal qualifications and blood relations in Canada;
- Canada has an occupation list based federal skilled program;
- Canada has a unique immigration program called arranged employment opinion;
- Canada requires applicants to submit IELTS language test scores with the application. The test is required to be given in general training module;
- Canada offers flexible criteria for sponsorship of parents after the applicants become permanent residents.

Quebec Skilled Worker program has been devised under the Canada-Quebec Accord on Immigration. Skilled and self employed professionals not qualifying under federal skilled worker program but keen on immigrating to Canada should seriously get their profile assessed under the Quebec skilled worker program. - Age of applicant and where applicable spouse AND children; Quebec skilled program is one of the few programs that offers credits for children and their age;
- Qualifications of applicant and where applicable, of spouse;

- French language skills of applicant and where applicable, of spouse;
- Where applicant does not know French language, his willingness to learn French language;
- Area of experience

# New Zealand Resident Visa

It is a 5 year multiple entry Permanent Resident Visa. After 3 years of stay in New Zealand, a permanent resident can apply for citizenship.

## Eligibility:

- Bachelor's or Master's Degree;
- Relevant work Experience of 2 years onwards;
- IELTS required(General Training module);
- International Exposure is an added advantage to your profile;

# Hong Kong Quality Migrant Admission Scheme

The Quality Migrant Admission Scheme is an entrant scheme for Hong Kong which is based on a quota. This program is for skilled professionals and entrepreneurs who intend to live and work in Hong Kong. All the qualifying criteria are assessed on a Points Based Test and then allotted a quota.

## Eligibility

- Higher the educational qualification more the points
- More the experience, especially in senior level positions, more are the chances that you will qualify
- Issued initially for one year; the visa gets 2 more extensions up to seven years when the holder can apply for permanent residency.
- Hong Kong does not offer citizenship
- Good English language skills are expected

## Fee Plan:

# Denmark Green Card

Denmark Green Card is a multiple entry Residence permit initially issued for 3 years and then extended on various terms; one can apply for residency after 7 years and citizenship after 10 years.

## Eligibility:

- Master's Degree is mandatory in most occupations; though exceptions exist for some including IT and software applicants;
- Relevant work Experience is normally expected and applicants with experience of 2-4 years or more are likely to qualify;
- Course of study should ideally match with the nature of work and it should fall under the positive list of Denmark;
- IELTS not required( If your highest degree is in English that would be fine); but offering IELTS test report helps in overall assessment;
- Applicants with aptitude for learning foreign languages should ideally apply under the option as long term successful settlement requires one to be able to converse in Danish Language.
